## UNANIMOUS CONSENT AGREEMENT

### **Ann Donnelly (Cal. No. 139)**

*Ordered,* That following Leader remarks on Tuesday, October 20, 2015, the Senate proceed to executive session to consider the nomination of Ann Donnelly, of New York, to be United States District Judge for the Eastern District of New York.

*Ordered further,* That the time until 11 a.m. be equally divided for debate on the nomination in the usual form; that upon the use or yielding back of time the Senate vote without intervening action or debate on the nomination, that following disposition of the nomination the motion to reconsider be considered made and laid upon the table with no intervening action or debate; that no further motions be in order to the nomination; that the President be immediately notified of the Senate's action and the Senate then resume legislative session. (*Oct. 8, 2015.*)
