UNANIMOUS CONSENT AGREEMENTS

Suspension of Rule XXXI - Judicial Nominations

Ordered, That all judicial nominations received by the Senate during the 114th Congress, first session, remain in status quo, notwithstanding the provisions of Rule XXXI, paragraph 6, of the Standing Rules of the Senate. (*Dec. 15, 2015.*)

Ordered, That at 5 p.m. on Monday, January 11, 2016, the Senate proceed to executive session to consider the nomination of Luis Felipe Restrepo, of Pennsylvania, to be United States Circuit Judge for the Third Circuit.

Ordered further, That there be 30 minutes for debate on the nomination equally divided in the usual form; that upon the use or yielding back of time the Senate proceed to vote without intervening action or debate on the nomination, that following disposition of the nomination the motion to reconsider be considered made and laid upon the table with no intervening action or debate; that no further motions be in order; that the President be immediately notified of the Senate's action and the Senate then resume legislative session.
