UNANIMOUS CONSENT AGREEMENT

Elaine C. Duke (Cal. No. 24)

Ordered, That following Leader remarks on Tuesday, April 4, 2017, the Senate resume executive session for the consideration of the nomination of Elaine C. Duke, of Virginia, to be Deputy Secretary of Homeland Security, with the time until 12 noon equally divided in the usual form.

Ordered further, That at 12 noon, the Senate vote on confirmation of the nomination with no intervening action or debate, and that if confirmed, the motion to reconsider be considered made and laid upon the table, and the President be immediately notified of the Senate's actions.
