Ordered, That upon the conclusion of morning business on Monday, October 18, 2021, the Senate proceed to executive session to resume consideration of the nomination of Christine P. O'Hearn, of New Jersey, to be United States District Judge for the District of New Jersey, with all provisions under the previous order in effect.

Ordered further, That cloture having been invoked on the nomination of Gustavo A. Gelpi, of Puerto Rico, to be United States Circuit Judge for the First Circuit, all post-cloture time be considered expired, and the Senate vote on confirmation of the nomination at 5:30 p.m.

Ordered further, That if the Gelpi nomination is confirmed, the motion to reconsider be considered made and laid upon the table, and the President be immediately notified of the Senate's actions.

Ordered further, That at 11:30 a.m. on Tuesday, October 19, 2021, the cloture motion on the O'Hearn nomination ripen.

Ordered further, That with respect to the motion to invoke cloture on the O'Hearn nomination, the mandatory quorum call required under Rule XXII be waived. (*Oct. 7, 2021.*)
