Ordered, That following the prayer and pledge on Wednesday, May 18, 2022, the Senate proceed to executive session to resume consideration of the nomination of Barbara A. Leaf, of Virginia, to be an Assistant Secretary of State (Near Eastern Affairs).

Ordered further, That at 11:45 a.m., the Senate vote on confirmation of the nomination of Jennifer Louise Rochon, of New York, to be United States District Judge for the Southern District of New York.
